Historian (see attached): Dr. Schwab reported on upcoming displays, work on Patrick Tavern, committee consultation, and CPP training. Dr. Schwab noted a query regarding Cayuga Lake Bank robberies and told a delightful tale of a 1967 robbery thwarted by baby Mary Beth Bianconi, who lived

next door. The child's perfectly timed wail so startled the would-be bandits that they abandoned their plan and escaped via Cayuga Lake.

Old Business

Water Update: Mayor Bennett reported on a meeting with the Village, Wells College, the Cayuga County Water & Sewer Authority (CCWSA), and the Cayuga County Department of Health (CCDOH). The CCDOH is concerned with the CCWSA timeline given Wells College Water Plant past struggles with turbidity and runoff, coupled with the shallow intake pipe, during significant storm events. The CCWSA is working toward a County referendum in November 2020 to create a Southern Cayuga Water District as a supplemental water source to Owasco Lake, for Cayuga County. The CCDOH requested a "Plan B" from the Village in case the CCWSA plan is delayed or not implemented.

Mayor Bennett, Village Engineer Ken Teter, and representatives of the engineering firm Barton and Loguidice met with CCWSA to determine whether the Village's proceeding to seek funding on its own would be in conflict with the Authority's plan. With assurance that it would not, the group discussed possible funding sources and a tentative timeline for a decision on a specific local plan.

The Preliminary Engineering Report (PER) identified two primary viable options. One possible "Plan B" option is building a Village plant to service just Village water/sewer users and Wells College. The other option is extending the CCWSA pipe (with water from Owasco Lake) that services the Town of Springport, along Route 90 through the Town of Ledyard into Aurora. Lawyers for the Village and Wells College are working on reviewing the Water Agreement between the two entities in order to move forward with either of the aforementioned plans. Discussions between the Village Board and Village Engineers will begin in early February and public meetings on the water plant options could begin by the end of February.

Solar Law: The Village Board scheduled a work session for January 20, 2020 at 9:00 a.m.
