## **Announcements**

**Mayor:** Mayor Bennett reminded the Trustees of the Water Information meeting on March 3, 2020 at 6:00 p.m. and instructed the clerk to notify residents on the water meter email list.

**Trustee Murphy:** Trustee Murphy discussed with the Board, interest from a local Veterans agricultural group in selling their products in the village. Trustee Murphy suggested Patrick Tavern as a potential site, but The Board encouraged the group to contact Wells College about joining their Farmer's Market on Saturdays, April-October. Trustee Murphy will follow-up with them.

**Trustee Bates:** Trustee Bates notified the Board of a "Trees for Tribs" program sponsored by the Community Science Institute. Residents along stream beds may receive up to 3 trees to plant along their property to help alleviate run-off.

# **Visitor Welcome**

**Laura Holland:** Ms. Holland referenced her recording of a November 8, 2006 Planning Board meeting where the Planning Board gave conditional site plan approval to the placement of her neighbor's house. Ms. Holland noted that her neighbor acknowledges in the recording that water run-off from one property to another is "illegal". Ms. Holland reiterated that water run-off from her neighbor's has been flooding her family's property for years and is now backing up on the village sidewalk creating a safety hazard. Ms. Holland submitted a USB copy of the recording for the Village Board.

**Pat Foser:** Ms. Foser commented on misinformation being spread throughout the village that accuses the Village Board of being anti-solar. Ms. Foser notes that land on Poplar Ridge Road, owned by Wells College, is under consideration for a 20-acre solar array and there is legitimate concern over allowing a large array within the village.

Ms. Foser explained that she consulted Cayuga County Real Property and noted that Wells College has millions of dollars' worth of property, including along Poplar Ridge Road that is tax exempt, though Trustee Van Orman an employee of Wells College questioned her figures. Ms. Foser added that the lack of taxes from Wells College and the decrease in water/sewer funds, due to empty houses and short-term rentals, is having a significant impact on the Village taxpayers.

Ms. Foser went on to address perceived lobbying of Wells College and the Inns of Aurora by Village Board members which, upon consultation with municipal attorneys, per Ms. Foser, opens the Village to an Article 78 lawsuit.

# **Reports**

**Code Officer** (see attached): Officer Doyle reported on recent permit activity and monitoring of current projects.

**Historian** (see attached): Dr. Schwab reported on the "Scoundrels & Scamps" display at the History Center, grant preparation for Patrick Tavern, recent queries and Community Preservation Panel training.

**Miscellaneous:** Mayor Bennett is conferring with DPW Superintendent, Kurt Wilmot and Village Treasurer, Deborah Brooks, on a new flat rate for sewer charges, separate from the water rates.

Trustee Bates reported that she is working with the Cayuga Lake Watershed Intra-Municipal Organization to help recruit more municipalities. Mayor Bennett noted that Owasco Lake groups are very organized, and the IO should be consulting with them, especially given the recent County Water report which hardly acknowledges Cayuga Lake.

# **Old Business**

**Ethics Policy:** The Village Board discussed revising the current policy, though Mayor Bennett noted that previously the Village Board requested that the Village Attorney be present for this discussion. Trustee Bates distributed an example that the New York State Conference of Mayors (NYCOM) recommends. Trustees Bates, Bianconi, and Van Orman believe the current policy is too strict, given how few people reside in the village. Mayor Bennett and Trustee Murphy countered that the current policy protects the

Board and only once in the past 8 years has a Trustee been asked to recuse themselves. The Board also disagreed on personal financial gain vs perceived impropriety.

#### Local Law #2 of 2020:

# VB RESOLUTION 20-04 OF 2020 RESOLUTION INTRODUCING LOCAL LAW #2 OF 2020 ENTITLED THE WAIVER OF THE MAXIMUM REAL PROPERTY TAX LEVY LIMIT

WHEREAS, the recent enactment of Chapter 97 of the Law of 2011 placed limits on the amount of real property taxes that may be levied by or on behalf of any local government thereby place a "tax levy limit" on municipalities that is found in General Municipal Law § 3-c; and

**WHEREAS,** subdivision 5 of General Municipal Law § 3-c expressly authorized the Village Board of Trustees to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the Village Board of Trustees for one fiscal year; and

WHEREAS, by adoption of this local law, the Village Board of Trustees hereby reserves the right to override the limit on the amount of real property taxes that may be levied by the Village of Aurora and authorized the Village Board of Trustees to adopt a budget for fiscal year 2020 in excess of the "tax levy limit" as defined by General Municipal Law § 3-c; and

WHEREAS, this is a Type II action pursuant to 6 NYCRR §617.5(c) (20 & 27) and is otherwise exempt from environmental review pursuant to the New York State Environmental Quality Review Act ("SEQRA"); and

WHEREAS, At a regular meeting of the Village Board of Trustees of the Village of Aurora, County of Cayuga, State of New York, held at the Village Hall, 456 Main Street, Aurora, New York, at 7:00 p.m. on February 24, 2020, the following members of the Village Board of Trustees being present:
