Clinic Scheduled for COVID-19 Testing

A clinic is scheduled for individuals to be tested for COVID-19. This is the nasopharyngeal viral testing swab, not the antibody test. The Cayuga County Health Department has been following New York State Department of Health (NYSDOH) criteria for testing since early March. As the criteria has changed, we have expanded our testing.

These drive-thru clinics continue to offer testing for those who are experiencing symptoms or were in direct contact with a confirmed case. Meeting new criteria, the clinic has expanded to essential workers and most recently those employees working under Phase 1 and returning to work under Phase 2. Essential workers include, **but are not limited to**: grocery store, convenience and hardware store employees, restaurant workers, first responders, law enforcement, correction officers, healthcare providers. Phase 1 employees include those working in: construction, agriculture, forestry, fishing, hunting, retail workers, manufacturing and wholesale trade. Phase 2 employees include those working in: office settings, real estate, essential and Phase 2 in-store retail, vehicle sales, leases and rentals, retail rental, repair and cleaning, commercial building management and hair salons and barbershops.

This clinic is also open to household members of these workers and employees, including children ages two and older.

The Cayuga County Health Department will be offering a drive-thru COVID-19 clinic on:

- **Tuesday, June 2, 2020 from 4:00pm – 6:00pm**
- The drive-thru clinic is **by appointment only**.
- Individuals need to make their own appointment.
 - **Employers should not make appointments for their employees, as we need to collect specific, individualized information on each person.**

- When making your appointment we need your:
 - **Legal name (not nicknames)**
 - Home address
 - Insurance information

- If the policy is under another person's name, we need his or her legal name and date of birth.
- If you do not have insurance, write No Insurance in each required field.
- Phone number that we can use to call you with results.
- There are three appointments for each timeslot. If one swabbing station is full, select a different one.

Essential worker testing clinics held on May 9, May 11, May 12, May 14, May 19, May 22 and May 26 resulted in 701 individuals being tested, resulting in 697 negative results and 4 positive results. Results from our May 26 clinic are still pending.
